Comment by resident that the format of the Budget is hard to follow and no benefits are shown with salaries. Treasurer Miller responded that the format is specified by New York State and followed by all municipalities. The salaries are shown separately from benefits. Mayor Burke added that Broome County is working on increasing the sales tax distribution for municipalities for the County 2014 budget. Workers Compensation coverage with other carriers is being explored although the Village will have to remain with Broome County until the recent claim is satisfied (about 5 years.) The overall tax increase is 6.8%. (About \$33/yr on a \$60,000 home)
