PUBLIC COMMENT:

Question from former Trustee Horoschak requesting the plan for street repairs. Mayor Burke
responded that the Village has about \$78,000 in CHIPS funding to use. The first project will be
Phelps St (from Chenango St to the Rt. 7 ramps) once Trustee Cashman has been informed that all

utility work is done on the street. The Town of Dickinson requested extra work be done on upper Phelps St and Mayor Burke will be meeting with them to determine their ability to cover the extra costs (about \$125,000). Chenango St from the Rt 7 bridge to the Town of Fenton line will be patched until the County does work on the Town of Fenton portion of the street or other remedy is determined. Attorney Kline indicated that NYS abandoned the Village section of the street when the highway was put in. Mayor Burke is working with Broome County to determine a long term plan for that section of the street. The curbs on Chenango Street are the responsibility of the Village.

 Question from Mrs. Wood regarding plant growth along the highway. The vegetation along the ramps belongs to NYS. They have cut their maintenance programs and have not maintained the areas along highways and ramps for the past several years. Village DPW does some maintenance around intersections for safety purposes.
