#### **Parks/Public Works:**

1. Awaiting paving of portions of Wayne Ave, Gregory Ave, and Elizabeth Street by Broome Bituminous, to be paid with CHIPs funding.

2. Street paving large patch work is scheduled for selected areas around Kinney, Miller, and Newton and Chenango.

3. The Village is taking part in a multi-jurisdictional program of signage for the Two Rivers Trail program, that will highlight walking routes and trails extending from Owego to Chenango Bridge, and passing through Port Dickinson. One large sign will be placed in the Port Dickinson Community Park exhibiting historical photos of the Village on one side and a map of the Chenango River on the other. The signs are being designed this Fall, with installation sometime next summer.

Village Historians Bob Blakeslee and Roger Shaller have been very helpful in the program effort. The signs are paid by a cost-sharing program with the State paying 80% and the Village 20%. Total cost is approximately \$19,000.

The Port Dickinson Police Department received 121 Complaints, they, assisted other agencies 7 Times and issued 20 traffic tickets made 2Criminal Arrests, 1Violation arrests and issued 2 parking tickets.

## RESOLUTION APPROVING CONSOLIDATION OF VITAL STATISTICS REGISTRATION DISTRICTS BETWEEN THE TOWN OF DICKINSON AND VILLAGE OF PORT DICKINSON.

WHEREAS, the Town of Dickinson ("Town") has been assigned by New York State as Vital Statistics Registration District 355, and the Village of Port Dickinson ("Village") has been assigned by New York State as Vital Statistics Registration District 320, and

WHEREAS, the Town Clerk, whose office has served as registrar for the Village, has requested the approval of the Town Board to formally consolidate the Town and Village into one primary registration, namely the District of the Town of Dickinson under Vital Statistics Registration District 355, and

WHEREAS, the two Registration Districts previously existed as one Registration District from 1881 to 1926, and the Town Clerk has been handling registrations in both municipalities since that time under the separate District numbers, and

WHEREAS, the formal consolidation of the Registration Districts would benefit the public by reducing the administrative and not result in a loss of services to either municipality,

NOW, therefore be it RESOLVED, by the Board of Trustees of the Village of Port Dickinson that consolidation of the Town and Village registrar functions under the Town's registration number, namely Vital Statistics Registration District 355 the Town's registration, is approved, pending necessary approvals of all other required entities, including the Town, Broome County and New York State Department of Health.
