Administration/Community Association: Written report on file with the Village Clerk

#### **Parks/Public Works:**

1. Concrete curb cuts are scheduled to begin Monday, July 20th, with removal of existing sections that Monday and Tuesday, and form setting and pouring of new concrete later in the week. This will be done at the 4 corners of

Kinney and 2 areas mid-block on Phelps. NYSEG is also planning to do work on Kinney the same week, with replacement of the gas main and all laterals to homes on the block.

2. The Public Works sweeper is permanently broken. Parts for the 30+ year old machine are no longer made or stocked, so it will be salvaged. We expect to use Town equipment to brush clean our Park trails.

3. The new bench is now installed at the Beacon Park and it looks nice and hopefully is facing in the right direction. We thank Rick Lewis for the bench and paying for the concrete slab.

4. The reservations for the Park baseball and softball field brought in \$225 this year and that goes to defray Park maintenance costs.

5. The first meeting of the Town of Dickinson's 125th Anniversary Planning Committee was held last night. There will be a big birthday party event at Otsiningo Park, but you will have to wait awhile--it will be from 11am-4pm on Saturday, September 17, 2016. That is 2016, not 2015.

6. WeatherMaster staff were scheduled to look at the continuing problem with water seeping through the masonry into the upper front stairwell area. Mark scheduled an appointment with them and they were to report their findings and recommendations. Both DPW staff felt it best to contract out the repair work due to scaffolding and other issues. We are still looking at all options.

**Planning Board**: The Planning Board met on July 7,2015 to review the proposed zoning change labeled "A new section 65 (33) (a) prior to the Village Board action at their July 14, 2015 meeting.

#### **Public Safety:**

The Port Dickinson Fire Department responded to 14 calls in the month of June These calls are broken down as follows, 5 fire calls and 9 medical assistance calls. 8 calls in the Village, 4 calls in the Town of Dickinson and 2 call in the Town of Chenango.

The Fire Department also offered 15 hours of training (8.5 present 87 man hours)

The Port Dickinson Police Department received 101 Complaints, they assisted other agencies 4 times, they issued 4 parking tickets and 15 Traffic tickets.
