FROM THE MAYOR: Our 2015-16 tentative budget does not increase our tax rate. This is primarily due to the increase of total assessed valuation of the village and the management of your Village Board, Clerk and Treasurer in controlling costs. This being done while maintaining the quality of life and the services we all have enjoyed. We are continually facing unfunded mandates from NYS and Federal Agencies in regard to storm water, drainage and numerous other directives. We are continuing the plans to merge our Public Works Department with the Town of Dickinson and will keep you informed of this schedule.

Recent news articles listed the Village as being "Fiscally Distressed." This audit relates primarily to the budget of 2013-14. The Comptroller referred to the Villages practice of using the surplus fund balance to minimize tax increases. In our response to NYS we stated "it was our intention while completing the annual budget to propose the minimum annual tax increase for our residents that would sustain our operations. This has been our goal for the last several years even prior to the Governors initiative of the Tax Cap. In using these surplus funds to retain the lower tax increases we always felt we had maintained what we believed to be a respectable fund balance to fund emergency type expenditures and non-recurring expenses based on past experiences. This also takes into account that many of the residents of our Village are on limited personal income and thus are not in a position to readily accept significant increases to local taxes. On an annual basis we did adopt a balanced budget by identifying and estimating expenditures to provide the services that the Village provides to its residents. We then estimated all sources of revenue to fund these services."

EMERGENCY FLOOD WATER CONTROL

PUMPING FACILITY. The construction of this new facility located adjacent to Watson Avenue at the levee will continue this Spring. This pump will have a propane powered engine thus eliminating the need for emergency generators in the event of a power failure. Also to be installed is a concrete pond and ramp where portable pumps can be safely located in the event of the need for additional pumps. Monitoring equipment and remote cameras to detect water levels on both sides of the levee will also be installed.

The current 6,000 gallon per minute pump will be replaced by a 9 to 10,000 GPM pump. This is a NYSDEC project that has been contracted out to a local construction company. We are grateful to Senator Libous and his staff for assisting us with this project.

BUILDING PERMITS are MANDATORY

The following require permits (not limited to) All New Structures & Construction including In & Above Ground Pools, All Decks, Certain Size Sheds, Hot Tubs, All Additions, Fire Place/Wood Burners, Porches and *Handicap Ramps *Virtually all Handicap Ramps per the NYS Building code do not comply and would require a variance. The Village passed a resolution to allow these noncompliant ramps <u>only for the temporary period that</u> they are needed, but still require a permit.

CALL THE BUILDING INSPECTOR @ 771-8233 WITH ANY QUESTIONS <u>PRIOR</u> TO INITIATING YOUR PROJECT. THIS WILL ALLOW YOU TO AVOID DELAYS, LEGAL ACTION & ADDED COSTS. Please allow time for the Inspector to return your call.

You can pick up permit applications at the Village Hall. PLAN AHEAD! If you initiate construction without a permit the permit cost increases to \$100.

YARD WASTE PICKUP: Starts Tuesday*April 7.

ALL DEBRIS MUST BE IN SOLID CONTAINERS. Max. 40lbs. Overweight containers/bundles will not be picked up. <u>NO PLASTIC BAGS. BRANCHES MUST</u> <u>BE TIED IN 4 FT. LENGTHS</u>. Place containers/bundles between the sidewalk and the curb <u>after 2PM on</u> <u>Mondays.</u> **If the preceding Monday is a Holiday then pickup will be on Wednesday so place containers to the curb on Tuesdays*. **FREE SHADE TREES** and Free Planting. The Village Tree Restoration Program funded by the Nimmonsburg Rotary Club will have 25 free shade trees available for Village residents. Please call the Village Hall 771-8233 and reserve one. **SPRING TIME VOLUNTEER PAINTERS**: painters needed to spruce up some of our public spaces. Leave a message at the Village Hall for Trustee Bob Aagre if you would like to donate a few hours. No experience necessary only a desire to make their community look better.

PARK FUNCTIONS: If you wish to reserve the Park Pavilion, Ball Fields etc. call the Village Office ASAP. Don't wait and miss out. Village residents have priority until April 1.

CODES TO BE ATTENTIVE OF:

- Discharging/Mowing Grass into the street is illegal.
- <u>Garbage, Recycling and Lawn Debris</u> <u>Containers,</u> may be placed to the curb the day prior to the day of pickup<u>. For lawn debris that</u> <u>would be 2PM on Monday</u>. Containers must be removed from the curb area no later than 9PM the evening of that pickup. All debris must be in suitable containers to prevent blowing and scattering. *Please be considerate of your neighbors!*
- Canine Waste: you must clean up after your dog. Violation is a \$25 Fine and potential seizure and impoundment of the dog. 22-3A.

In addition to our Code Enforcement Officer, violations are reported by the Police and Public Works employees.

<u>WATER RUN OFF</u> – The EPA & the NYSDEC is asking all residents to be aware of what we allow to flow into the waters of streams and rivers in respect to runoff. Our street drains are marked to indicate which ones flow directly into rivers and streams. Please be cautious in applying any fertilizers/weed killers with respect to overuse or misuse.
