A LOCAL LAW OF THE VILLAGE OF PORT DICKINSON AMENDING CHAPTER 60 OF THE VILLAGE CODE ENTITLED "VEHICLES AND TRAFFIC"

Be it enacted by the Board of Trustees of the Village of Port Dickinson as follows:

Section 1.

Chapter 60 of the Village Code, as amended, be and hereby is further amended by this Local Law as

follows:

A. § 60-37 Schedule X: No Parking at Any Time.

Remains the same except adds the following:

B. § 60-38 Schedule XI: Standing Prohibited.

Remains the same except substitutes the following:

Section 2.

All Ordinances, Local Laws and parts thereof inconsistent with this Local Law

are hereby repealed.

Section 3.

This Local Law shall take effect when it is filed in the Office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

VILLAGE OF PORT DICKINSON NOTICE OF PUBLIC HEARING

PLEASE TAKE NOTICE that a public hearing will be held by the Board of Trustees on January 8, 2013 at

6:00 P.M. at the Port Dickinson Elementary School, 770 Chenango Street in said Village regarding the adoption of a

Local Law of the Village of Port Dickinson for the year 2013 amending Chapter 30 of the Village Code entitled

"Dumping" as follows:

§ 30-3A (Garbage and Rubbish Removal), paragraph A, is hereby amended to provide as follows:

A. The person in control of any private lands in the Village shall arrange at his own cost and expense for the removal at least once a week of all garbage and rubbish including but not limited to furniture and appliances generated from said lands which shall be placed at the curb line not earlier than 2:00 PM on the day preceding the collection day in suitable containers including garbage cans, recycling bins, and lawn debris containers or securely stacked in bundles so as to prevent blowing and scattering. All of such containers shall be removed from the curb area by said person in control of such lands and stored at a location adjacent to or behind the structure on said premises by 8:00 PM on the collection day.

PLEASE TAKE FURTHER NOTICE that the environmental significance of said proposed Local Law will

be reviewed by the Board of Trustees incident to and as a part of said public hearing.

Any resident of the Village of Port Dickinson shall be entitled to be heard upon said proposed Local Law at

such public hearing. Copies of said proposed Local Law are available for review at the Village Clerk's Office.
