## **OLD BUSINESS:**

- 1. Tennis court bids were opened and were within the amount that was allowed by FEMA for the Project. Trustee Aagre has submitted a request to FEMA to amend the thickness of asphalt from 2 ½" to 4" as recommended by the Engineer and bidders. The Attorney and Engineer are reviewing bids and the bid will be awarded at the 6/11/13 meeting.
- 2. Treasurer Miller reported that the final information for the 2012-2013 Fiscal Year is not yet available. The Sewer Fund balance is approximately \$31,000 and the Water Fund Balance is approximately \$72,000.

## **NEW BUSINESS:**

- 1. Trustee Aagre indicated that some households have put out large quantities of yard waste (up to 3 truckloads) which is taxing on DPW time commitments. Trustee Cashman will look into the possibility of borrowing or purchasing a chipper to compact amounts at the landfill. Consideration will be given to only allowing materials to be collected that are placed in cans.
- 2. Mayor Burke reported that DOT grants have been announced and the information is available online.
- 3. The Town of Binghamton has tables and chairs they are getting rid of. Treasurer Miller is trying to obtain 12 tables and 96 stackable chairs for use in the 2<sup>nd</sup> floor room.
