### COMMITTEE REPORTS:

Administration/Community Association: Written report on file with the Village Clerk

**Parks/Public Works:** 

1. The milling and paving projects for Phelps St. and Kinney St. have been completed, as have all the concrete curb cuts for this calendar year. The project on Kinney allowed for a better contouring of the surface to hopefully reduce any ponding of water following storms. An extra 25 tons of asphalt was needed to accomplish this contouring.

2. Another meeting of the 125th Birthday Committee for the Town of Dickinson was held. A change was made in venue for the Sept. 17, 2016, event. It has been moved from Otsiningo Park to our Port Dickinson Community Park. The P.A.S.T. (Preservation Association of the Southern Tier) may have its annual House Tour the same day, possibly featuring classic historic homes in the Village.

3. Nimmonsburg Rotary purchased the 2 oak and 4 maple trees needed by the Village residents for Fall planting requests. We thank them for the donation. Any residents or businesses in the Village wanting free trees can call Village Hall and leave their contact information, and I will be back in touch and arrange the planting. There is NO CHARGE.

4. Saturday, October 3rd, 2015, is River Bank Cleanup Day here in Broome County. All along the rivers, individual volunteers and service clubs will be assisting with trash removal, in the continued effort to help clean the waters that are used for drinking and for recreation. The events are being coordinated by Beth Lucas at the County level through Debbie Preston's office and the Village has requested volunteers to help pull another 100 tires out of the muck along our shores. IF we are fortunate to be assigned a team of volunteers from B.U, as we were 2 years ago, a large walk-in dumpster from Bert Adams will be left in the Park on Friday, Oct 2nd and positioned by our DPW. The volunteers and other members of the community who wish to help can fill it on Saturday with tires (only tires in the dumpster), and then the dumpster will be removed on Monday, with the tires going to Tallmadge Tire for recycling. We still have to pay the \$4 (\$6 for truck tires) per tire fee, but it saves our Village trucks from trying to haul them up to the County tire recycling area.

### **Public Safety:**

The Port Dickinson Fire Department responded to 9 calls for assistance, these calls are broken down as follows, 5 fire calls and 4 EMS calls, we had 4 calls in the Village, 1 call in the town of Dickinson, 2 calls in the town of Fenton, 1 in the town of Chenango and 1 call in the town of Kirkwood. The fire department offered 10 hours of training in the month of August.

The Port Dickinson Police Department received 103 Complaints, they assisted other agencies 7 times, they issued 1 parking tickets and 3 Traffic tickets, they also made 13 criminal arrests mostly relating to the graffiti I mentioned last month.
