- 4. Trustee Cashman has talked to NYSEG and NYS DOT regarding a light pole at Phelps St & Service Rd that was hit by a truck in 10/15. He has determined that there a 5 other light which are owned by the Village. There are several options with respect to the Phelps St light a) do nothing, b) have DOT put up a new light at no charge to the Village c) have DOT install a new light and change the other 5 lights to LED d) have NYSEG replace all of the lights with wood poles (which may incur a charge).

Trustee Cashman will also request NYSEG inspect the intersection of River & Mill Sts. To see if trees need to be trimmed. It has been reported that the intersection is very dark.
