Proposed LOCAL LAW OF THE VILLAGE OF PORT DICKINSON AMENDING CHAPTER 30 OF THE VILLAGE CODE ENTITLED "DUMPING"

Be it enacted by the Board of Trustees of the Village of Port Dickinson as follows:

Section 1.

Chapter 30 of the Village Code (Dumping) adopted January 13, 1998 as Local

Law No. 1-1998, as amended, be and hereby is amended by this Local Law as follows:

§ 30-3A (Garbage and Rubbish Removal), paragraph A, is hereby amended to provide as follows:

A. The person in control of any private lands in the Village shall arrange at his own cost and expense for the removal at least once a week of all garbage and rubbish including but not limited to furniture and appliances generated from said lands which shall be placed at the curb line not earlier than 5:00 PM on the evening preceding the collection day in suitable containers including garbage cans, recycling bins, and lawn debris containers or securely stacked in bundles so as to prevent blowing and scattering. All of such containers shall be removed from the curb area by said person in control of such lands and stored at a location adjacent to or behind the structure on said premises by 8:00 PM on the collection day.

Section 2.

All Ordinances, Local Laws and parts thereof inconsistent with this Local Law are hereby

repealed.

Section 3.

This Local Law shall take effect when it is filed in the Office of the Secretary of

State in accordance with Section 27 of the Municipal Home Rule Law.

ADOPTION BY THE BOARD OF TRUSTEES OF THE VILLAGE OF PORT DICKINSON OF LOCAL LAW NO. 7-2012

WHEREAS, a resolution was duly adopted by the Board of Trustees of the Village of Port Dickinson for a public hearing to be held by said Board at the Port Dickinson Jeanne & John D. Wilfley Community Park Pavilion in said Village, at 6:00 o'clock P.M. on July 10, 2012 to hear all interested parties on a proposed Local Law entitled "A Local Law of the Village of Port Dickinson Amending Chapter 30 of the Village Code Entitled 'Dumping'", as amended, and

WHEREAS, notice of said public hearing was duly advertised in the Press & Sun-Bulletin, the official newspaper of the Village, on June 24, 2012, and posted on the Village Clerk's sign board on June 20, 2012, and

WHEREAS, said public hearing was duly held at the Port Dickinson Jeanne & John D. Wilfley Community Park Pavilion at 6:00 o'clock P.M. on July 10, 2012, and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof, and

WHEREAS, pursuant to Part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) ("SEQR"), it has been determined by the Board of Trustees that adoption of the proposed Local Law does not constitute an action as defined and could be considered without further regard to SEQR, and

WHEREAS, the Board of Trustees, after due deliberation, finds it in the best interest of the Village to adopt said Local Law,

NOW, THEREFORE, the Board of Trustees hereby adopts said Local Law as Local Law No. 7-2012 entitled "A Local Law of the Village of Port Dickinson Amending Chapter 30 of the Village Code Entitled 'Dumping'", a copy of which is attached hereto and made a part hereof, and the Village Clerk be and she hereby is directed to enter said Local Law in the minutes of this meeting and to enter said Local Law in the Local Law Book of the Village of Port Dickinson, and to give due notice of the adoption of said Local Law to the Secretary of State.

RESOLUTION AUTHORIZING VILLAGE OF PORT DICKINSON TO PARTICIPATE WITH BROOME COUNTY STEERING COMMITTEE UPDATE OF BROOME COUNTY HAZARD MITIGATION PLAN

WHEREAS, in 2008 all Broome County municipalities adopted the Broome County Hazard Mitigation Plan (the "HMP") and it was approved by FEMA, and

WHEREAS, by federal regulation the HMP musts be formally updated each five years in order for participating municipalities to be eligible for various FEMA grant programs, and

WHEREAS, the Broome County Department of Planning and Economic Development is willing to lead

such HMP update effort, and

WHEREAS, the Village of Port Dickinson is desirous of participating in the steering committee charged with preparation of portions of the updated HMP,

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of the Village of Port Dickinson in regular session duly convened that the Mayor be and hereby is authorized to execute the attached Letter of Intent to participate in the Broome County Hazard Mitigation Plan Update Project.

This resolution shall take effect immediately.
