VILLAGE TAXES: Great news this year. NO TAX INCREASE. Your Board has been able to maintain a solid financial plan, continue our preventive maintenance program on street repaving along with setting aside money for future equipment purchases and unforeseen emergencies. This sound financial result is a product of vigorous work and attention to detail by every Trustee on your Board. Sue Fox our Village Clerk and Cheryl Miller our Treasurer are also major contributors to your Village operating so efficiently. Thanks to all of you for your hard work!

SEWER & WATER RATES: MORE GOOD NEWS. Due to the aggressive campaign that we launched 4 years ago to closely monitor and anticipate the increasing rates at the Binghamton Johnson City Joint Sewage Treatment Plant we have been able to stabilize these rates for this period. Due to our long term agreement with the Town of Fenton we also have been able to maintain our current rate for water consumption.

MILLENIUM PIPELINE UPDATE: We have met with the Millennium officials and are hopeful that the pipeline will go outside of the park at the north end and then under the highway. There is a slight chance some area in the park may be used for equipment as the pipe is buried under the river. Activity is planned for 2007.

COMMUNITY ASSOCIATION ACTIVITY: Please note the sign on the front lawn of the Village Hall that has the current activity of the PDCA listed on it. The Officers and Coaches are always looking for assistance on numerous activities

YARD WASTE PICKUP- Lawn debris pickup will be on Mondays beginning April 4, weather permitting. All debris must be in containers (Max. 50lbs.) Branches must be tied in 4 ft lengths. NO PLASTIC BAGS or TRASH. Place containers or bundles between the sidewalk and the curb.

PLEASE CONSIDER COMPOSTING your lawn waste whenever possible. The Village Landfill has a limited capacity and the alternatives will prove very costly.

Regarding Contractor Garbage Pickup. Put containers out to the area between the sidewalk and the curb the evening before and remove them as soon as

possible after pickup. Please help keep Port Dickinson beautiful by not leaving containers at the curb.

SIDEWALKS: Over the next several months we will be initiating an effort to notify home owners of sidewalks that are unsafe or in disrepair. We have received numerous complaints from our residents regarding this situation. The Board has reviewed and revised the code in regards to sidewalks to make the code more enforceable. Code Enforcement will notify you by mail if you are in violation. Our Enforcement Officer will work with you on this to make adjustments uncomplicated. It is also our hope to also have a list of contractor's rates available for the residents to assist in compliance.

We have a great relationship with our T-own Officials.
